Services Required*	-Physical & Health Education - PHE 10, Active Living, Outdoor Education, Fitness and Conditioning -Arts: Dance, Drama, Music, Visual Arts, Cross-discipline/Interdisciplinary Arts	After the course is activated, the Learner’s OTIS account will be credited with \$125 in PO funds to be used to pay Face to Face fees OR directed to fund an approved supplementary course or 3 rd party service (i.e. Dance or Music Lesson, or workshop/fieldtrip) No fees apply unless.... -learner attends a CLUB then there is a club fee . I.E. Gym Club -learner attends a corresponding CLASS then there is a class fee and no PO funding . I.E. Active Living, Outdoor Education, or Art Class
Individualized*	Modernized INDV course unique to a learner with approved course outline created by parent/learner and approved by the teacher (includes Independent Directed Studies - IDS courses) Non modernized courses in CANVAS (these will be phased out prior to the 2019/20 academic year) Modified courses for Special Education Learners with Individualized Education Plans -IEPs	After the course is Activated the Learner’s OTIS account will be credited with \$75 in PO funds to be used to purchase course related curriculum

The BC Ministry of Education limits the funds a DL School can issue to a maximum of \$600/learner, therefore a learner will be limited in how many courses in these (*) categories may be activated in one Academic Year
